### **Tuition Agreements**

I understand that the enrollment fees are not refundable.

I understand that if I choose to remove my child midyear from an Earth School educational program for homeschooled children, I will be responsible for the remainder of the year's tuition, and refunds are not available.

For new students enrolling midyear, one full-day visit to an Earth School class per child is permitted free of charge, with or without parents in attendance. A trial period of one month may be allowed for new families, with full payment for that month and a nonrefundable enrollment fee, received in advance.

I understand that tuition is calculated on an annual basis and that there are no fee reductions for holidays, illness, vacations, or emergency closings, including snow days.

In the case of prolonged illness, or other severe emergency, a full refund minus one month's tuition will be considered.

Something Good in the World reserves the right to dismiss a child whose contact, influence, physical needs, or condition, is deemed disruptive or potentially harmful to him/herself, the staff, or students. SGITW reserves the right to determine if our programs are serving your child's best interests. If not, a pro-rated refund will be given.

Partial scholarships are available according to genuine need, for families who have been enrolled in Earth School programs for at least one year. In order to apply for a scholarship, parents must submit a letter, specifying their financial need, by May 1st preceding the school year for which the request is being made. Scholarships will be granted on a "first come first served" basis. Although every effort will be made to meet each family's needs, Something Good in the World cannot guarantee that the full amount requested will be available to all those who apply.

## **Medical and Safety Agreements**

I understand that personal contact information, medical forms, and immunization records are required before my child may be admitted to classes.

I hereby grant parental consent for minor medical (first aid) treatment during my child's enrollment at Earth School programs. Should I be unavailable during an emergency, I grant permission for the staff to secure emergency medical treatment for my child. The staff will always attempt to contact the parents or pediatrician first.

The child and parents agree to abide by the rules and regulations set by Something Good in the World for the safety, health and welfare of the students and the staff.

I understand that the Earth School staff members are by requirement, mandated reporters to any suspected child abuse.

I understand that Something Good in the World cannot be held responsible for any injuries that may occur at Hilltop Hanover Farm outside of class time. We therefore urge parents to ensure their children are always properly supervised before and after school.

Something Good in the World cannot be responsible for any item that is lost, stolen or damaged. We recommend that you do not allow your child to bring valuables to class.

I understand that my child may be interacting with domesticated animals, and/or may be tasting foods prepared as part of these programs
